### **Our September Speaker is Chris Army**

Chris Army is a Licensed Battlefield Guide at Gettysburg National Military Park. Chris has led tours around the Gettysburg Battlefield for groups of all demographics from, private car tours to West Point Cadets and other military organizations. In 2005, Chris wrote an article for Blue & Gray Magazine about the North Carolinian Brigade of Alfred M. Scales and is currently working on several Gettysburg-related projects. Chris served as a co-moderator of Military History Online and is a Past Board President of the Adams County Historical Society. Chris helped develop the Culpeper Battlefield Tours company providing tours of the Brandy Station Battlefield and the 63/64 Winter Encampment. Chris is a product and business leadership trainer for Johnson Controls. Chris is a faculty member of the Gettysburg Foundation's Leadership program "In the Footsteps of Leaders." He lives in Dover, PA with his wife, Connie.

Chris will examine the Federal plan developed by the new commander of the Army of the Potomac, George G. Meade, and will take a look at the various planning activities involved in setting up this defensive line. He will evaluate why the Pipe Creek Line is important – or wasn't.


